CORE is working to bring high quality education to rural Tanzania. We provide grants to Twegashe Integral Development (TID), a Tanzanian NGO, whose current major program is to construct and operate Twegashe Primary School in Bushasha Village, Tanzania. In January 2024, we welcomed 30 pre-kindergartners and 30 kindergartners to Twegashe, bringing current enrolment to 180 students in grades pre-K through grade 4. In 2024, CORE completed all phase 2 construction, and continued to fund school operations. School facilities now include seven classrooms, cafeteria, kitchen, library, administrative offices, staffroom, and six teacher duplexes. In September 2024 CORE began a fundraising campaign to construct additional staff housing, create a scholarship reserve for Twegashe graduates, and fund continuing school operations. CORE is committed to high quality education. Our school program emphasizes community engagement, strong academics, and a focus on the whole child. Classroom instruction is in English so students will be successful in secondary school. We provide a nutritious breakfast and lunch for children, with fruits and vegetables from our school garden. We are committed to environmental sustainability. (continued on Schedule O)

We also promote environmental sustainability through the curriculum and programs aimed toward the wider community. Bushasha village community engagement is high, with over 175 volunteers in 2024! In addition, there were 36 U.S. volunteers, including Michael Banobi and Jeannette Banobi, who spent nine months in the village volunteering and overseeing the entire project. U.S. volunteers also included 12 students from Lakeside School in Seattle who spent three weeks leading camp activities for Twegashe students through Lakeside's Global Service Learning Program. CORE's financial commitment to TID includes ensuring that CORE has enough in reserves to fully fund school operations for the current and following school year.
